VOTE BY MAIL INFORMATION

As of December 31, 2022, all Vote-By-Mail requests on file expired. If you previously had a request on file, you may need to update your request for 2024. Any registered and qualified voter in Flagler County may choose to vote by mail. You may request a mail ballot in person, by mail, fax, online or by telephone. To request your ballot mailed to an address not on file, provide your name, address, date of birth, either FL Driver's License or last 4 of Social Security Number, address to which the ballot is to be mailed and signature on a Vote-By-Mail request. Mail ballot request deadline is March 7, 2024.
